Privacy Policy

Collecting information about you

Personal information that can be used to identify you as an individual. The type of information we collect from you depends on how you use our website.

Cookies

Cookies are used on this website to collect information on how you use the site. This information may include your browser type, operating system, IP address, and the referring sites. This information is anonymous and only used for statistical and website development purposes.

Subscription/Newsletters

Contests and Promotions

On occasion we may have contests and promotions that, in the event you wish to participate, will require you to supply identifying information, such as your name and email address. In some cases, third parties will be involved in the contest or promotion and this information may be disclosed to them. If any such disclosure is made it will only be made in accordance with or Privacy Policy and any use by these third parties will be indicated within the terms of contest or promotion.



Payment Information

When you make a booking with us online you will provide information such as your name, contact details and payment information. We use this information to identify and process your booking. When a booking is made through our website customer credit card details are collected at each booking. This information is stored by us in our software provider.

Disclosing information

We do not disclose personal information about you to advertisers. In order to operate the website or deliver a service we may disclosure personal information to external service providers these include IT system providers and external archiving services. We will not otherwise disclose your personal information to other companies without your explicit consent.
